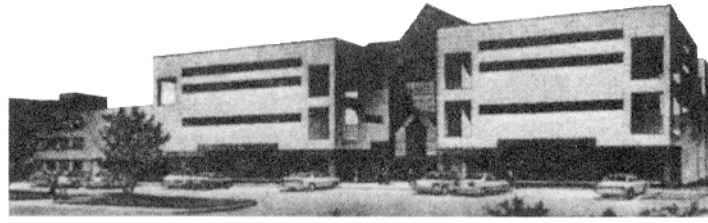

News Release-Update

February 21st, 2024

Update – Isaiah has not yet been located. The Sheriff's Department continues to follow up on all leads and have received tips ranging from northern Illinois to Manitowoc, WI. We have used multiple resources to continue focused searches in the Village of Vernon and have checked video surveillance for multiple businesses in the area. We've conducted countless interviews and worked with the National Center for Missing and Exploited Children (NCMEC) to expand this search and distribute Isaiah's information nationwide.

On February 19, 2024, we received a tip that Isaiah may have been spotted near the intersection of Edgewood Ave and Center Dr in the early morning hours of February 5th. Based on that information, we have expanded our search area to the north utilizing personnel, drones, and additional K9 resources.

We appreciate all the tips we have received and the response from the public in attempting to locate Isaiah. We ask that residents continue to check their outbuildings and home security cameras for any possible sightings of Isaiah. If you believe you have seen Isaiah or have information on his whereabouts, please call (262) 446-5090.

Missing Juvenile

The Waukesha County Sheriff's Office is asking for the public's assistance in locating 16-year-old Isaiah Cramer. Isaiah was last seen on the evening of February 4th, 2024, around Maple Ave and Center Dr, in the Village of Vernon. Isaiah requires daily medication that he does not have with him. There is nothing to indicate Isaiah left against his own will. Isaiah is a light-skinned black male, 5'8" to 5'10," approximately 200 pounds and was last seen wearing dark-colored sweatpants and a dark-colored hooded sweatshirt.
