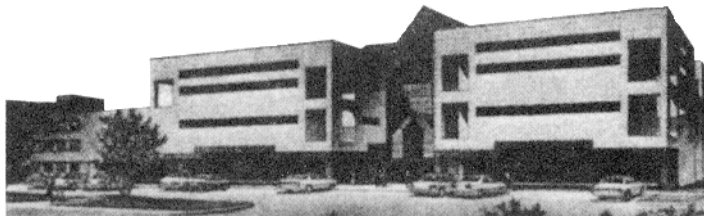

## **Sex Offender Information Bulletin**

**Date: March 7, 2024**

The following information is being provided to our community pursuant to Wisconsin State Statutes 301.46(2m), which authorizes law enforcement agencies to inform the public of a sex offender's release when, at the discretion of the agency, providing the information will enhance public safety, awareness and protection. **The Sheriff's Department does not determine placement but is permitted by statute to notify the public of the release.** This offender was granted supervised release from his Chapter 980 Civil Commitment by the courts in April 2023. The offender was placed under strict supervision by the Wisconsin Department of Health Services and the Wisconsin Department of Corrections. The reason for this updated notice is a change of address for this offender. **The offender must comply with the supervised release rules and comply with requirements of lifetime Sex Offender Registration and lifetime GPS monitoring.**

**This sex offender has served the prison sentence imposed on him by the courts.** The individual who appears on this notification has been convicted of a sex offense. Further, his criminal history places him in a classification level which reflects the *potential to* reoffend.

The offender, under the supervision of the Department of Corrections, Division of Community Corrections, will be living in the location listed below. **He is not wanted by the police at this time. This notification is not intended to increase fear; rather, it is our belief that an informed public is a safer public.**

Sex offenders **have always** lived in our communities, but it wasn't until Act 440 (June 1997) that law enforcement is now able to share this information with the community. Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated. Please understand that such abuse could potentially end law enforcement's ability to do community notifications. We believe **the only person who wins if community notification ends is the sex offender**, since sex offenders derive their power through secrecy.
